

# Safety Training in Oil and Gas Can Help Save Lives and Reduce Injuries




In the oil and gas industry, where safety hazards are an everyday reality, substantial safety training plays a crucial role in supporting employee safety and reducing financial losses.



## Oil and gas workers face many safety risks

While drilling and servicing a well, the different industrial processes that oil and gas industry workers execute can expose them to a range of **safety hazards**, including vehicle collisions, struck-by/caught-in/caught-between hazards, explosions, and fires, falls, etc.

Despite a slight rebound in 2021, workplace incident rate has **gone down** in the U.S. oil and gas industry over the years, likely thanks to **greater and better implementation of safety training programs**. However, lives continue to be lost due to preventable safety incidents.




## Safety hazards injure and kill workers

Likely due to the decrease in oil and gas production during the **COVID-19** pandemic, the number of fatal occupational injuries **dropped sharply** in 2020 and 2021.

Nevertheless, **58** oil and gas workers **lost their lives** during work in the United States in 2021.

**Organizational factors** and **human error** combined with **safety hazards** often cause such fatal incidents.



## Incidents are avoidable

**Inadequate safety measures** in organizations as well as **insufficient safety awareness** in employees can prove lethal when combined with already-existing safety hazards.

Leading causal factors assigned to fatal incidents\* in the global oil and gas industry, 2012-2021





## Safety incidents have significant financial consequences

Other than **causing injuries** and **loss of lives**, safety risks also have serious **financial repercussions**. Neglected safety hazards interrupt business and incur direct and indirect expenses.

Costs resulting from a single burn injury (in US dollars)



To cover the cost of a single burn injury, companies need to generate more than **\$3 million** in sales revenue.


