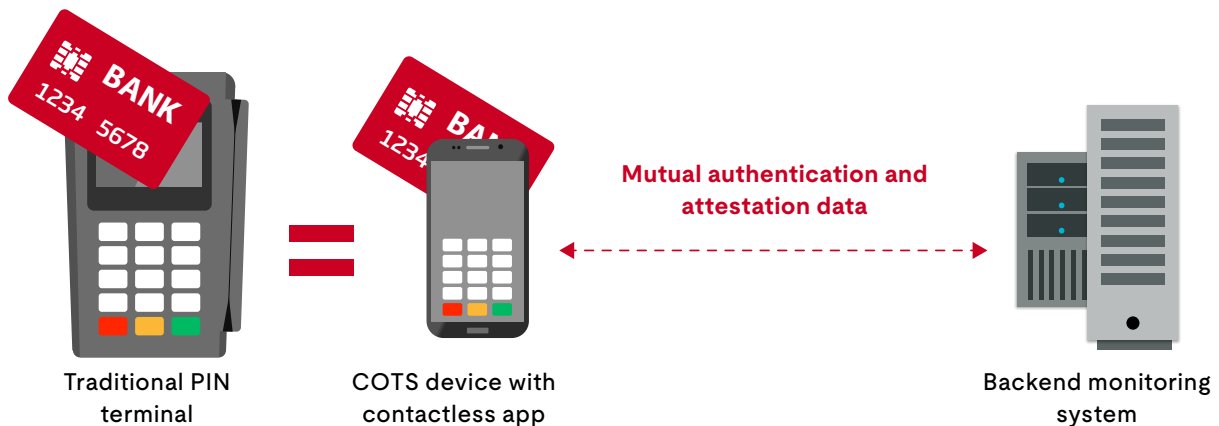

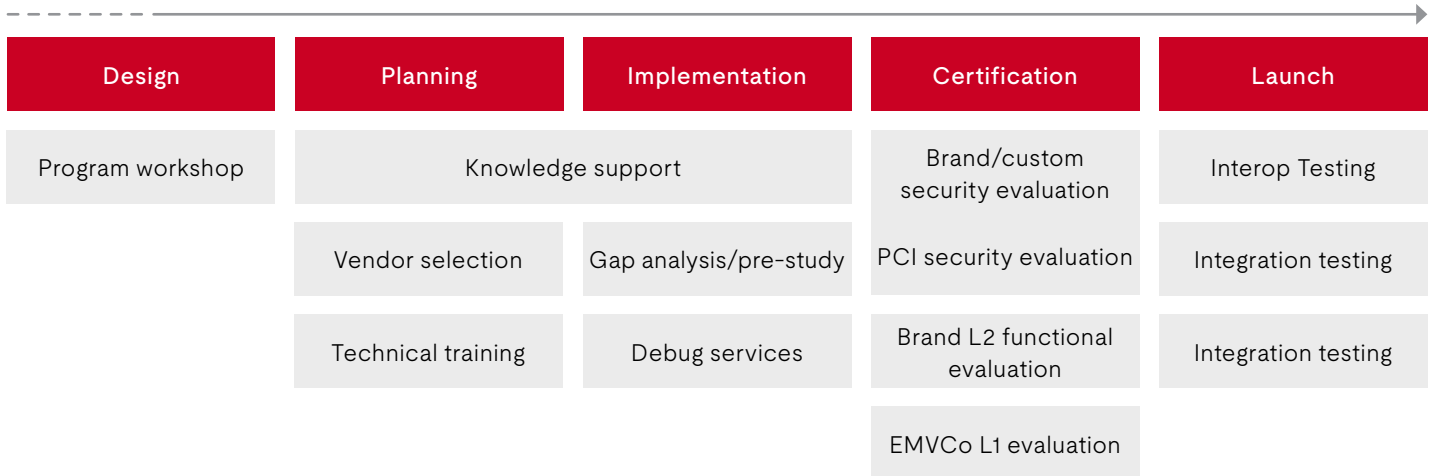
Not just an app
