A. UL 2700 goes into effect

New Products

New certification projects will be expected to comply with and quoted for UL 2700. Existing quotes already issued for projects under the old standards shall be honored through the quote expiration date. Project orders resulting from accepted quotes scoped to older standards shall be conducted as originally quoted (products assessed for certification to the older standard). Certifications completed in 2024 against older standards shall be valid for 12 months and shall either be recertified against UL 2700 or decertified in 2025.

Existing Certified Products

Products currently ECOLOGO® certified against any of the replaced standards can maintain certification status under that standard until the 2025 certification valid through date or Nov. 1, 2025, by which certification will need to be moved to UL 2700 or withdrawn. Major formulation changes to existing certified products will be expected to comply with and quoted for UL 2700.

D. Remaining products certified to old standards shall be decertified and removed from UL SPOT by Nov. 1, 2025.

R. All replaced standards retired/withdrawn by Dec. 31, 2025.

FAQs

Our formulas have not changed. Can we automatically roll over our certification to UL 2700?

No, because UL 2700 includes several new criteria. To comply with the updated and new criteria, a full ECOLOGO® Certification evaluation to UL 2700 shall be required for existing products currently certified to the old standards.

If the manufacturing facility has not changed and an on-site audit has been conducted within the past three years, no on-site audit is needed. New manufacturing facilities and existing manufacturing facilities that have not been audited on-site within the past three years will require an on-site audit as part of the ECOLOGO Certification to UL 2700.

Are all criteria specified in the UL 2700 standard required?

Yes, only designated product category-specific criteria are not required for all cleaning and cleaning-related products.

Will recertification to UL 2700 affect licensing fees?

No, annual licensing fees for existing certified products shall be grandfathered and not recalculated or increased specifically for UL 2700 certification.

How much will recertification to UL 2700 cost?

UL 2700 certification pricing starts at \$4,575 (USD).

How does this affect private labels?

Private labels can acquire UL 2700 certification once the associated primary manufacturer's product(s) have earned UL 2700 certification. If product label(s) require updates, product SKUs or names changes, a label review, updated agreement, and/or attestation may be needed. If the primary manufacturer allows the ECOLOGO® Certification to expire and does not recertify against UL 2700, the private labeler may initiate UL 2700 certification for the product(s) and then own the listing upon certification. For decertified products, how much time do we have to sell through the current inventory?

A termination date shall be provided within the decertification notice. Customers shall cease using any Marks on, or in connection with, the decertified product(s) as of the date specified in the notice, including any use of any ECOLOGO® Marks, or any reference to either UL Solutions or any UL companies, in the marketing, promotion, and/or advertising of such product(s).
